## 17/17 CHAIRMANS REPORT AND CORRESPONENCE RECEIVED

Correspondence had been received regarding Common Ground. It was noted that following several written complaints from residents Dacorum were contacted and visited the site. Dacorum reported that the land that had been fenced is owned by the shop unit and is not Highways or DBC owned land. The fence erected is below the 1 metre height required for any fencing adjacent to a highway, therefore the recommendation from Dacorum was that Common Ground are not in breach of a planning control.

# 19/17 REPORT FROM BOROUGH/COUNTY COUNCILLOR

Cllr Riddick informed council that the permission to extend the graveyard had been granted on the 12<sup>th</sup> May. It was noted that the former Project group was now officially registered as a charity being the Chipperfield Burial Ground Trust. Cllr Laverack also informed Cllr Riddick and Cllr Adeleke that the trust were granted £1000 by the Parish Council in the annual grants.

Cllr Riddick informed council of a Dacorum housing problem regarding a council house in the village.

## 1.OPEN SPACES REPORT

FCC had its final meeting with Colin Chamber on the 18<sup>th</sup> April.He did a small amount of pruning before leading the group on a tour of previous works.
