The Clerk is to chase Highways on the situation with the white lines at the crossroads It was noted Cllr Roberts had agreed to chase Peter Wright, at the meeting held on the 19th June , this was minuted.

1.OPEN SPACES

Cllr Bathurst informed council there had been 3 new litter bins installed in the village, they are enclosed with a top tray for cigarette butts & replace open basket type bins. Cllr Bathurst informed Council that there had been problems with the path running parallel to Whippendell Hill.

Cllr Bathurst and the Clerk have been liaising with Clayton Rae the Countryside Access Officer at Dacorum. Highways are currently looking into this and liaising with Clayton Rae.

2.YOUTH AND EDUCATION

Cllr Luff informed Council the school had a lot of new teachers. Caroline Moore the Head also being fairly new in her position. The school has a creditation of good and is working hard to achieve excellent.

3. POLICE REPORT

Councillors were given copies of crime figure reports for May and June In May Chipperfield had a total of 5 crimes and 13 in June Bardi has been asked to provide more information on the monthly figures.

5. ALLOTMENTS

Cllr Bathurst spoke of the allotment AGM ,and as agreed at the meeting , more posters will be put up to advertise the vacant plots. There have been 2 enquiries about plots, one being from a resident who would like to run occasional educational days .Council voted against this as being a commercial venture, and anyone other than holders were not permitted on the allotments.

The fence behind Blackwells has been mended by Cllt Bathurst and the warden The breaking up of the heavy cast iron bath blocking a pathway had begun.

64/17 DRIVESAFE

Cllr Luff spoke of there not being any evidence of reduction in speeding after Drivesafe sessions have taken place. There appears to be little motivation, and the funding closed last year. Cllr Luff told informed Council he would be seeing David Lloyd the Police & Crime Commissioner next week.
