## 28/19 CHAIRMANS REPORT & CORRESPONDENCE RECEIVED

- 1. Bus Shelter Tower Hill Councillor Laverack informed members that the bus shelter on Tower Hill is dilapidated and needs replacing. Herts County Council have offered £7k towards the new bus shelter.

2. HAPTC 6<sup>th</sup> June 2019 – There is a course for Community Organisers Course in October 2019, please liaise with the Clerk if anyone is interested.

#### 29/19 FINANCE AND GENERAL PURPOSE

- Accounts Summary YTD Councillor Laverack informed members that at F&GP on the 19<sup>th</sup> June 2019, councillors looked through the YTD Summary, apart from few items being miscoded, there are no major adverse variance to report.
- b. Insurance Councillor Laverack informed all members that CPC has renewed the insurance with Came and Company for the current financial year.
- c. Clerks working hours and increase in the next scale Councillor Laverack informed members that the Clerk has now reduced her working hours from 26 hours a week to 22 hours a week. As the Clerk is coming up to her first year at CPC, it was recommended that the Clerk moves up to the next scale at 31 new (old scale 37). Due to reduction in working hours, the budget for 2019/20 will be within the budget.
- d. Little Wynch Councillor Laverack updated councillors on the development of the Little Wynch. DBC will follow up with the removal of the house sign, DBC to update CPC by 8<sup>th</sup> July 2019.

Councillor Riddick informed members that Garden Scene Development was approved at the Development Management Committee, the two applications on Longfield have been withdrawn. Councillor Riddick objected to Chantry View as did CPC, the application was approved by DBC.

## 31/19 REPORT FROM WORKING GROUPS

#### 1. OPEN SPACES

- a. **Bins** Councillor Bathurst informed members that CPC approved to purchase two bins, one for Scatterdales and one on The Common behind the Cricket Club.
- b. Councillor Bathurst met with The Friends of Chipperfield, she has organised another meeting in August which she will host.

## 2. YOUTH AND EDUCATION

Councillor Heaphy informed members all the clubs are performing well, St Paul's School had the Offsted report, the inspection seems to have gone well. Councillor Heaphy will report once the formal report has been submitted to St Paul's School.

## 3. POLICE REPORT

Councillor McGuinness informed members no crime report received by CPC. Councillor Laverack updated all members re the youth gang that are going around destroying council property. The incident has been reported to PCSO Bardhyl.

## 4. HIGHWAYS

**Potholes** – Councillor McGuinness informed members that Peter Wright has not acknowledged his email requesting a meeting. Councillor Laverack suggested in liaising with Councillor Roberts to find out the correct procedure in dealing with highways, especially if Councillor Roberts has stepped down with his responsibilities.

#### 5. PLANNING

**Bucks Hill** – Councillor Bryant informed members that the site on Bucks Hill was placed on auction site for £30k, it was sold for £296k.

**Royal Oak Community Asset** – The Clerk informed members she is in the process of completing the Nomination for listing as an Asset of Community Value,

**Allotment AGM** - Councillor Bathurst informed members that Allotment AGM will take place on the 3<sup>rd</sup> July 2019 in the Small Hall at 7.30 pm.

**Shed on the allotment** – It was proposed by the Clerk to have a shed to store the council equipment, however, Councillor Laverack mentioned that in view of the Garden Scene Development being approved there is a possibility the Council will have sufficient storage space.
