### **THE HERTFORDSHIRE (TEMPORARY CLOSING OF VARIOUS ROADS IN CHIPPERFIELD DURING THE 'CHIPPERFIELD REMEMBRANCE DAY PARADE') ORDER 2025**

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 16(A) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads:-

1. that length of The Common, Chipperfield from its junction with Kings Lane south westwards to its junction with Queen Street, a distance of approximately 345 metres.

An alternative route will be via The Street, Dunny Lane, Windmill Hill and The Common.

2. that length of Kings Lane, Chipperfield from its junction with The Common north eastwards to its junction with Kings Close, a distance of approximately 157 metres.

An alternative route will be via The Street, Chapel Croft and Kings Lane.

3. that length of The Street, Chipperfield from its junction with Kings Lane north westwards to its junction with Forge Close, a distance of approximately 229 metres.

An alternative route will be via The Common, Windmill Hill, Dunny Lane and The Street.

4. that length of The Common, Chipperfield from its junction with Kings Lane south eastwards for a distance of approximately 154 metres.

An alternative route will be via The Street, Dunny Lane, Poles Hill, The Green, Dimmocks Lane, Sarratt Road, Redhall Lane, Chandlers Lane, Toms Hill, Bucks Hill and The Common.

The sections of roads will be closed between the hours of 10.45am and 11.15am on Sunday 9 November 2025, when signs are in place.
